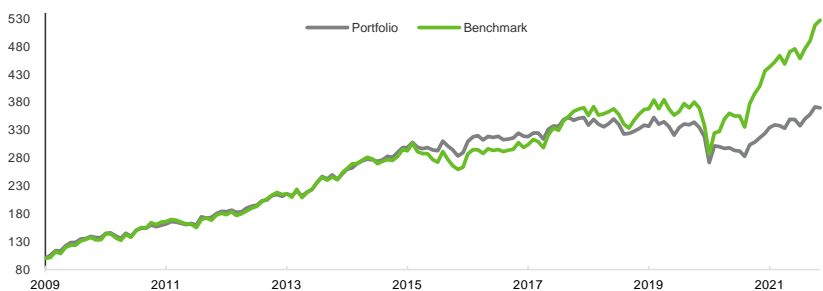
Investment objectives and strategy

The Fund manager is, however, also permitted to invest in fixed income securities and offshore investments as allowed by legislation. Equity investments are typically volatile by nature and subject to potential capital loss.

This fund is suited for long-term investors seeking exposure to the equity market to achieve long-term capital growth and who can tolerate investment volatility in the short to medium term.

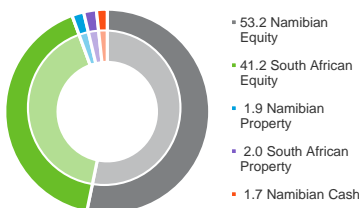

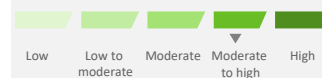
