Terms and Conditions

1. Conversion of foreign currency to Namibia Dollar will take place at an exchange rate quoted by First National Bank of Namibia Limited (Registration No: 2002/0180) acting through its RMB Global Markets division ("RMB") at spot (i.e. a deal where the delivery of funds takes place within two business days, on the specified value date) or at a forward exchange rate (i.e. the sale or purchase of foreign currency at a fixed rate of exchange, for delivery at a specified future date). Payments required in currencies other than that of the deposit will be converted at the time of the withdrawal at an exchange rate quoted by RMB at that time.
2. Any profits or losses arising from fluctuations in exchange rates are for the applicant's account and RMB does not underwrite or in any way guarantee the Namibian Dollar value in any currency of any balance or amount in another currency.
3. All transactions over the foreign currency accounts are subject to the provisions of the Exchange Control Regulations of 1961 of Bank of Namibia as applicable from time to time.
4. Deposits and withdrawals are subject to one business days' notice.
5. Transactions shall be made in accordance with the terms of the mandates as held by RMB. Telephonic, electronic and/or faxed instructions are not acceptable forms of instruction, unless RMB holds a waiver and indemnity for electronic instructions duly signed in terms of the mandates held by RMB. In the case of a company, a resolution by the Board of Directors of the Client must accompany the waiver and indemnity
6. Notwithstanding the foregoing RMB shall be entitled to debit any of the Client's accounts held with RMB in settlement of any amounts owing by the Client to RMB in respect of any FCA account.
7. Any debit interest on FCA accounts must be converted to Namibia Dollar on the 1st business day of the next month.
8. Statements will be produced and send to the client according to the selected frequency
