Read these competition rules carefully. These competition rules (“rules”) explain your rights and duties under this competition. If you take part in this competition or accept any prize, these rules will apply to you and you agree that the person running the competition (“the promoter/s” or “FNB”) can assume that you have read and agreed to be legally bound by these competition rules.

1. The FNB Swipe Like a Boss Competition (“Competition”) is organised and conducted by First National Bank of Namibia Ltd (“FNB”).
2. The Competition will run from 5 November 2018 at 06h00 and will strictly close on 5 February 2019 at 23h59. Transactions made after the closing date will not be considered by FNB.

### **WHO CAN QUALIFY?**

3. The Competition is open to all FNB Namibia Gold Lifestyle Account holders and FNB Namibia Gold Credit Card Account holders that are in good standing and entrants must be in possession of a valid ID or Passport.
4. Participants who are directors, members, partners, employees, agents of or consultants of FNB, its subsidiaries, holding companies, divisions and/or associated companies or of the advertising or promotion agencies or any other person who directly or indirectly controls or is controlled by FNB, will not qualify to participate in the Competition and will also not be eligible for any prizes.
5. By entering this Competition, all participants agree to be bound by these terms and conditions, and FNB’s decision regarding any issue with the Competition will be final and binding and no correspondence will be entered into.

### **HOW TO QUALIFY?**

6. To qualify, customers need to swipe with their FNB Gold Debit and / or FNB Gold Credit Card.
7. Participants may swipe their FNB Gold Debit and / or FNB Gold Credit Card as many times as they choose.
8. Winners will be determined based on the total number of swipes made by a Participant using their FNB Gold Debit and / or FNB Gold Credit Card during the Competition period.
9. FNB does not accept any responsibility for any transaction that is not delivered, received or is delayed or damaged due to technical reasons, including telecommunication failure on the part of the participant’s service provider, or otherwise.
10. Participants acknowledge and agree that they may incur costs or other charges ordinarily associated with using a FNB Gold Debit and / or FNB Gold Credit Card.

## **PRIZES**

11. The prizes consist of 30 x N\$10,000.00 (Ten Thousand Namibia Dollars) cash prizes which will be paid into the customers' Gold Debit or Credit Card account.

  - 5 Credit Card winners will be announced by 10 January 2019 with a cash prize to be paid into the winning Debit Card
  - 5 Debit Card winners will be announced by 10 February 2019 with a cash prize to be paid into the winning Debit Card
  - 5 Credit Card winners will be announced by 10 February 2019 with a cash prize to be paid into the winning Debit Card
15. The prizes do not cover any other costs of the winner whatsoever.
16. The prize is limited to cash which will be paid into the winners respective accounts used for swiping.
17. FNB reserves the right to substitute the prizes for an alternative prize of equal or greater value should the prizes promoted not be available due to unforeseen circumstances.
18. FNB will not be liable for any loss suffered as a result of incomplete or incorrect information provided.
19. ## **PUBLICITY AND DATA PRIVACY**

21. The prize winner must accept that his/her name and/or likeness may be announced in FNB's media publications or on the Internet for publicity or advertising purposes without additional compensation, except where prohibited by law.

## GENERAL

FNB reserves the right to shorten, extend, suspend the time period of the Competition or terminate the Competition whenever it should so choose for technical, commercial, or operational reasons, or for reasons beyond its control or generally for any reason whatsoever within their sole discretion. The Competition, its prizes, and terms and conditions may be amended by FNB, at any time during the Competition, and will be applied and interpreted within its sole discretion. In such an event, all participants waive any rights that they may have/purport to have in terms of this Competition, and acknowledge that they will have no recourse against FNB whatsoever.

To the extent permitted by law, FNB will not be liable in any way whatsoever, for any claims arising from loss, injury, damage or costs, suffered by a participant in relation to this Competition or the prizes offered, including but not limited to claims relating to defects in the prizes or any losses caused by such defects or losses arising from incorrect or inaccurate information supplied by participants.

28. Namibian law shall govern these competition terms and conditions and the courts of Namibia shall have exclusive jurisdiction.

### IMPORTANT:

- **You agree to indemnify the promoter(s) fully for any loss or damage the promoter(s) may suffer because you breached the competition rules. This means you agree to reimburse the**

**promoter(s) for the following: any loss or damage they suffer, any expenses and costs they paid or are responsible for. Legal costs mean costs on an attorney and own client scale.**
